#### NIH ESTABLISHES STANDARD THC UNIT TO BE USED IN RESEARCH

On May 7, NIDA, along with the National Cancer Institute; the National Heart, Lung, and Blood Institute; and the National Institute of Mental Health, published a notice in the NIH Guide directing researchers funded by these institutes to measure and report their findings from clinical research on cannabis using a standard unit of delta-9-tetrahydrocannabinol (THC) of 5 milligrams. #### PRESIDENTS FISCAL 2022 BUDGET RELEASED

On May 28, the White House released the text of President Biden's FY22 proposed budget. For NIH, the budget proposes \$45.453 billion or a \$2.517 billion increase in FY 2022, and \$1.853 billion, \$372 million over FY21, for the National Institute on Drug Abuse (NIDA), including \$405.5 million for HEAL.
