## MEDICARE PHYSICIAN FEE SCHEDULE FINAL RULE

On November 2, CMS issued a final rule that includes updates on policy changes for Medicare payments under the Physician Fee Schedule (PFS), and other Medicare Part B issues, on or after January 1, 2022.
