FEDERAL

Senate Introduces a Continuing Resolution and Clean FDA User Fee Package

On Sept. 27, the U.S. Senate introduced the Continuing Appropriations and Ukraine Supplemental Appropriations Act of 2023, which funds the federal government at current spending levels through Dec. 16, 2022. The continuing resolution (CR) allows Congress to extend the deadline and continue work on the federal appropriations process to fund the government for the fiscal year of 2023. In addition to federal funding, this legislation contains a clean 5-year FDA user fee reauthorization and additional authorizing supplementals.

The FDA user fee agreement is reauthorized every five years to enable the FDA to collect fees from brand drug, generic drug, biosimilar, and medical device manufacturers which allows the agency to hire additional review staff and expeditiously review product applications.

This must-pass legislative package contains many provisions that would "hold the FDA accountable with stricter deadlines on future negotiations with the medical industry, overhauling diagnostic regulation, dietary supplements and cosmetics reform, formula shortages, opioids, and animal studies."

The former version of the FDA user fee package contained riders including an animal studies provision with language similar to the FDA Modernization Act of 2021. This language "allows an applicant for market approval for a new drug to use methods other than animal testing to establish the drug's safety and effectiveness. Under this bill, these alternative methods may include cell-based assays, organ chips and micro physiological systems, sophisticated computer modeling, and other human biology-based test methods."

The current legislation does not contain animal studies language and is slated for a vote this week as the deadline for federal funding and FDA user fee agreements expires on Sept. 30.

ABROAD

Science: China Bets Big on Brain Research with Massive Cash Infusion and Openness to Monkey Studies

China recently launched the China Brain Project (CBP), a program focused on advancing research in neuroscience. The \$746 million investment into the CBP provides for a five-year plan to strengthen China's competitiveness on the world stage regarding neuroscience with non-human primates. This initiative coincides with the United States' Brain Research Through Advancing Innovative Neurotechnologies (BRAIN) Initiative and the European Union's EU Human Brain Project. China plans to collaborate with the U.S. and EU on neuroscience research, but most collaboration will have to take place at the International Center for Primate Brain Research because major airlines refuse to transport research monkeys abroad.

The goals of the CUSP project are to provide access to a repository where participating institutions can share standard procedures to be used in animal care and use protocols with the broader animal welfare compliance community. Having access to the database offers all those involved with the preparation and review of proposed activities involving animal research a valuable resource that can be used to improve consistency and reduce the administrative burden on investigators and members of the IACUC and IACUC support staff.
