# Veterans Medical Marijuana Research Bill Fails to Advance in Senate

A bipartisan package of veterans' bills was blocked on the Senate floor over Republican concerns about expanded research into medical marijuana use for veterans' pain management and mental health relief. The cannabis measure, one of five bills in the legislative package, passed out of the Senate Veterans' Affairs Committee with unanimous, bipartisan support in February but failed to gain the 10 Republican lawmakers needed to continue debate on the issue in the full chamber. # **House Labor HHS Subcommittee Hearing on NIH Budget Request**

On April 19, the House Labor HHS Appropriations Subcommittee held a hearing on the Fiscal Year 2024 budget request for the National Institute of Health (NIH). Ranking Member DeLauro called for more funding for the NIH, indicating that the President's proposed increase is too small. In response to questioning, Dr. Tabak said that keeping the NIH at FY22 levels would result in 5,000 fewer medical research grants for FY24. Read more <a href="here">here</a>.

#### **Biden Expected To Nominate NIH Director**

It has been reported that President Biden plans to nominate current National Cancer Institute (NCI) Director, Monica Bertagnolli, to run the National Institutes of Health. # **CMS Announces Medicaid Inmate Exclusion Flexibility**

On April 17<sup>th</sup>, the Centers for Medicare and Medicaid Services announced they would allow states to reenroll inmates 90 days prior to their release. This would allow patients to receive SUD and mental health treatment prior to their release, prepare them for continued treatment upon release, and ensure state and local governments are reimbursed for such costs.
