CPDD President's Column

Welcome to everyone as we begin the spring season. It is time to look forward to the 79th Annual Scientific Meeting of CPDD in the Hôtel Bonaventure, Montréal, Canada, June 17-22. This year will include several co-sponsored symposia with the International Cannabinoid Research Society (ICRS) on cannabinoid research. The ICRS will meet after CPDD in Montreal at the nearby Sheraton Hotel. The meeting program grid has been posted on the CPDD website. I would like to draw your attention to the President's Lecture on Sunday, June 18th: William Dewey has organized an outstanding panel of guests from the DEA, NIDA, and CPDD to discuss important issues with drug scheduling and the impact that it has on scientific research. Collectively, the Program Committee has put together a very informative meeting. I hope you will all plan to attend what should be an outstanding scientific conference in a fabulous environment.

In the January 2017 edition of Newsline, I emphasized the importance of basic science to the overall health and effectiveness of the College. There has been a marked decline in the number of basic scientists who attend the annual meeting on a regular basis. Even though the Program Committee continues to do an outstanding job of representing basic science in symposia, oral presentations

and workshops, the number of abstract submissions by basic scientists had dropped below 15% of the total submissions in recent years. Fortunately, there was an encouraging increase in submissions of basic science abstracts last year to just over 17% and I'm very pleased to report that we hit the 20% mark for the meeting in Montréal. This encouraging trend is due to a lot of hard work on the part of our membership. As part of this effort, a working group was formed to define better the needs of the College and specifically to identify what can be done to attract more basic scientists. Bill Fantegrossi (Arkansas) serves as chair and is joined by Kevin Freeman (Mississippi), Jun-Xu Li (Buffalo), Wendy Lynch (Virginia), and Shane Perrine (Wayne State). The group will be active for one year and will meet in person at the June 2017 conference in Montréal. They were asked to seek input from the membership and meeting attendees and to prepare a 1-page final report with 3-5 concrete action items for the Executive Committee and Board of Directors to implement next year. I anticipate that everyone who attends the annual meeting in Montreal will witness a significant difference in the scope and quality of basic science. Nothing attracts a crowd like a crowd.

The CPDD Board of Directors held its interim board meeting February 15-16 at the Diplomat Hotel, Hollywood, Florida. One of the key strategic areas that was discussed included public policy and

advocacy. The promotion of evidenced-based public policy is a central mission of the College. Since the 2016 Annual Scientific Meeting in Palm Springs, California, members of the College have been very active in promoting sound policy in the drug addiction arena. We provided input on the Synthetic Drugs Bill that had slated 300 new compounds for Schedule I. Friends of NIDA met on Capitol Hill for a briefing on the Adolescent Brain and Cognitive Development (ABCD) program. CPDD wrote endorsement letters in support of 1) nonhuman primate research in conjunction with the American Psychological Association Science Directorate; 2) the Comprehensive Addiction and Recovery Act (CARA) to increase funding for prevention and treatment of opioid misuse; 3) the DEA for resending temporary Schedule I for kratom and for streamlining the requirements for research with novel compounds through research exemptions; and 4) HHS Secretary Sylvia Burwell for tobacco cessation treatments via the US Preventive Services Task Force in conjunction with the American Psychological Association. Lastly, Sandy Comer and Bill Dewey have organized an Advocacy Day on Capitol Hill on March 28th for CPDD members to meet with their representatives in Congress. The College is fortunate to have a long-standing relationship with Van Scoyoc Associates Inc., a Federal Government affairs firm and independent lobbying company in Washington, D.C. They are instrumental in serving as a conduit between the College and government policy makers and have agreed to facilitate the event as part of their relationship with CPDD. The first Advocacy Day will target the Executive Committee and CPDD members who live or work close to Washington, D.C. with the intention to expand the scope of the event in future years. Given the transition in leadership in the White House and Congress, and the proposed NIH budget just released by the Executive Office, the timing for this effort could not be better.

A second key strategic area that was discussed by the Board of Directors was the need for CPDD to enhance its development activities. Two functions of the College selected as fundraising priorities were the Travel Award Program for Young Investigators and public policy and advocacy efforts. Our Travel Award Program is key to engaging young investigators who are new to our field, including those who would not otherwise be able to attend our Annual Scientific Meeting. Our advocacy efforts have been very successful in helping to shape important federal and state legislation and in maintaining research funding to support drug abuse research and treatment. In order to meet these challenges, our President-elect Alan Budney revived the Development Committee, and Marc Kaufman kindly agreed to serve as chair. This is strategic and timely given the finances of the College. The committee is charged with identifying revenue-generating ideas, providing a rationale for solicitation of development funds, and creating a policy for managing support by pharmaceutical and biotechnology companies.

I would like to close by welcoming our newly elected officers Meg Haney (President-elect) and Jack Bergman (Treasurer-elect), and board members Amy Janes, Geoff Mumford, Stacey Sigmon, and Mark Smith. They will assume their new roles in the College at the end of the Annual Scientific Meeting in June. It is a pleasure to have such a solid group of scientists and good citizens join the Board of Directors. Please take time to thank them in advance for their service to the College when you cross paths in Montréal. I very much look forward to seeing you all in June. Safe travels!

The main role of the ICRS is also to provide an open forum for researchers to meet and discuss their research.
